In continuation to this Office proceedings 1st cited, wherein it was communicated the approved Schedule of Rates for the year 2017-18 reformulated with basic prices after excluding VAT and Excise duty (which were subsumed under GST).

In order to revise the estimates of ongoing works executed after 01.07.2017 in compliance with GST Act, the Schedule of Rates (2008-09 to 2016-17) were reformulated with the basic rates (without VAT and Excise Duty) (*excluding those items which do not get affected by the adoption of GST including labour rates*) as furnished by concerned Engineers-in-Chief were placed before the Board of Chief Engineers(BoCEs) during the meeting held on 12.04.2018. The same are approved by the Board of Chief Engineers for adoption of all the Engineering Departments for revising the estimates as stated above for ongoing works executed after 01-07-2017.
