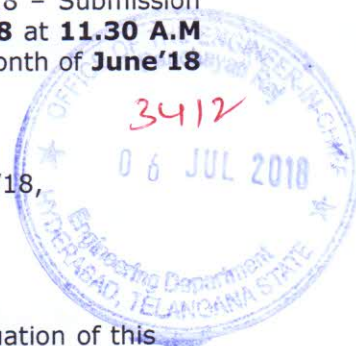

In terms of G.O.Ms.No.2, I & CAD Dept., Dt:10.7.2014, the Sub-Committee reviewed the quotations obtained by the Chief Engineer(P), Karimnagar, Superintending Engineer, Irrigation Circle, Rangareddy, Superintending Engineer, M&W Circle, Hyderabad, Superintending Engineer, Irrigation Circle, Nizamabad and Superintending Engineer, JCR DLIS Circle, Warangal in respect of Cement and Steel and the Engineer-in-Chief(PH&ME) obtained quotations from the Superintending Engineer(P.H), west circle, Hyderabad in respect of Public Health items for the month of June' 2018.

In finalizing the rates of Cement and Steel, the quotations obtained from TATA, VSP, SAIL, JSW & Shyam Steel are considered for realistic analysis. In respect of Public Health items the quotations obtained from M/s.TATA Steel Ltd., Mumbai, M/s Indian Steel Industries, Mumbai and M/s Sathavahana Ispat limited, Hyderabad is considered.
